## What's Going on in Fulton, IL?

July 25, 2013 - On my way back from the Blackhawk Hills Regional Council meeting in Rock Falls, I called Larry Russell, Mayor of Fulton, IL. Mayor Russell was gracious enough to give me a tour of Fulton's Downtown Commercial District, which is listed in the National Register of Historic Places.

Fulton Retail Development organization is renovating two buildings which will house Krumpets, a new Main Street restaurant. Renee Holmes, owner of Krumpets, hopes to open her restaurant in September 2013. Fifty-eight private citizens have pulled together

to create this retail revitalization fund. The group offers a rent-to-own option that would allow a renter to purchase property at a predetermined price and take possession as soon as 25 percent of the price - instead of the typical bank-required down payment - has been paid in rent. The effect of this incentive is to offer the ability to purchase a building with an interest-free down payment and no money down.


